CHARGE

I, Smt. AISHWARYA S.G., B.A., LL.B. & LL.M., I Addl. Civil Judge & J.M.F.C., Holenarasipura, do hereby charge you the above named accused persons as follows:-

That, on 29.02.2024 at around 1.30 pm, at Sunnakal Hosuru Village, falling within the jurisdiction of Holenarasipura Rural Police station, you accused No.1 to 9, in furtherance of common intention, due to a dispute over land near the land in Sy.No. 11/3, 11/2, the accused No.1 to 9, formed an illegal gang with the common intention of committing the crime and thereby committed an offence punishable U/sec. 143 r/w 149 of IPC within my cognizance.

That, on the above stated date time and place, with the same intention to commit the offence, you accused No.1 to 9, have Disturbance of public peace by creating an illegal assembly and thereby committed an offence of intentional insult punishable U/s.147 r/w 149 of IPC within my cognizance.

That, on the above stated date time and place, with the same intention to commit the offence, you accused No.1 to 9, have trespassed into the land of CW-2 and thereby committed an offence of intentional insult punishable U/s.447 r/w 149 of IPC within my cognizance.

That, on the above stated date time and place, you accused by voluntarily restrained CW2 from proceeding further and thereby committed

an offence punishable U/sec.341 r/w 149 of IPC within my cognizance.

That, on the above stated date time and place, with the same intention to commit the offence, you, accused No.2 holding both hands tightly of CW-3 with intent to outrage her modesty and thereby committed an offence of intentional insult punishable U/s. 354 r/w 149 of IPC within my cognizance.

That, on the above stated date time and place, with the same intention to commit the offence, you, accused No.4 and 5 have threatened with a machete and a scythe CW-2 and 3 with their life of dire consequence and thereby committed an offence punishable U/Sec.506(b) r/w 149 of IPC within my cognizance.

That, on the above stated date time and place, with the same intention to commit the offence, you accused No.1 to 9 have the stolen ragi grass belonging to CW 2, worth about Rs. 200,000/-, was tied to a load and carried 4-5 times by accused persons, hidden near the land next to the house of you accused No.7 and thereby committed an offence punishable U/sec. 379 r/w 149 of IPC within my cognizance.

That, on the above stated date time and place, with the same intention to commit the offence, you accused No.1 to 9 have threatened CW 2 and 3 with their life of dire consequence and thereby committed an offence punishable U/sec. 506 r/w 149 of IPC within my cognizance.
