**CHARGE**

**I, Smt. AISHWARYA S.G., B.A., LL.B. & LL.M., I Addl. Civil Judge & J.M.F.C., Holenarasipura,** do hereby charge you the above named accused persons as follows:-

That, on 05.12.2025 at about 1.30 pm, at Billenahally Village falling within the jurisdiction of Holenarasipura Rural Police station, You accused No.1 to 4, from proceeding further and thereby committed, when CW-1 and CW-2 were in an empty lot on the western side of the Billenahally Tharu Road, which passes to the east of the house where CW-1 resides, you, the accused No.1 to 4 have abused CW1 in filthy language by saying ಬೋಳಿ ಮಗನೆ

ಸೂಲೆ ಮಗನೆ ನವು ವಿಚಾರವನ್ನು ಮಾತನಾಡುತ್ತಿಯಾ and ಬೋಲೆ ಮಗನೆ ಕುಡಿದು ಕೊಂಡು ಬಂದು ನಮಗೆಲಾ ತೊಂದರೆ ಕೊಡುತ್ತಿಯಾ knowing that it would give provocation to CW1 and CW2 to breach the public peace and thereby you accused have committed an offence of intentional insult punishable U/s. 352 r/w 3(5) of BNS Act within my cognizance.

That, on the above stated date time and place, you accused No.1 have voluntarily assaulting CW-1 on the right hand with a machete that was lying there, you accused No.2 and 3 assaulting CW-1 with your hands and causing simple hurt and thereby committed an offence punishable U/sec. 115(2) r/w 3(5) of BNS Act within my cognizance.

That, on the above stated date time and place, you accused No.4 have voluntarily assaulting assaulting CW-1 on the right hand with a machete that was lying there and causing simple injuries and thereby committed an offence punishable U/sec. 118(1) r/w 3(5) of BNS Act within my cognizance.

That, on the above stated date time and place, you accused No.4 have voluntarily assaulting assaulting CW-1 on the right hand with a machete that was lying there and causing grievous injuries and thereby committed an offence punishable U/sec. 118(2) r/w 3(5) of BNS Act within my cognizance.

That, on the above stated date time and place, you accused No.4 have threatened CW1 with their life of dire consequence and thereby committed an offence punishable U/sec. 351(2) r/w 3(5) of BNS Act within my cognizance.
