It appears that in the seizure list there is no specific mention about any household articles but definitely it is there that the entire truck has been seized. It is to be noted that this household articles finds mention in the post seizure inventory which was produced before this court. As such, u/s 451 of Cr.P.C corresponding to 497 of BNSS, this court has the authority to pass necessary order of disposal in respect of these items.

The household items as mentioned in the petition are actually not connected with this case for which the goods should immediately be restored to its actual owner.
