**Chief Examination by Spl. P.P:**

From May 2018 I am working as a Medical Officer at Haveri.

On 17.03.2021 I conducted the PM of Ningappa Shiraguppa and found the external injuries:

- 1) 12x3 cm bone deep lacerated wound on occipital region.
- 2) 8x 2 cm on right parietal region (laceration seen)
- 3) Nosal bleeding oral bleeding seen.

**Skull and vertebrae** : Communicated fracture seen on occipital region.

**Mambrance:** Ruptured.

**Brain and spinal cord:** Subdural haemorrhage intact and normal.

The cause of the death is due to shock and haemorrhage due to head injury. In this regard I issued the PM report is marked as Ex.P-54, signature marked as Ex.P-54(a).

On the same day I conducted PM of one Ganesha Kundapura and found the external injuries:

1) Communated fracture seen on right side of skull measuring 8x3xbrain deep.

2) Blood was oozing from the wound.

**Skull and vertebrae** : Communicated fracture seen on parietal region.

**Mambrance**: Ruptured.

**Brain and spinal cord**: Subdural haemorrhage and extradural haemorrhage seen.

The cause of the death is due to shock and haemorrhage due to head injury. In this regard I issued the PM report is marked as Ex.P-55, signature marked as Ex.P-55(a).

If one person assaulted with MO-7 to 9 the above injuries may be caused.

**Cross Examination by Mr. UNG advocate for accused:**

I have not mentioned last page of Ex.P-54 and 55. I have not

identified blood group. It is correct to suggest that my self has written the PM reports. In the Ex.P-55 there is some corrections. It is not correct to suggest that one Doctor can not be conducted two PM. Generally prior to written PM report there was some notes. PM report is in the printed form.

Any PM report was mentioned in the register. Number has not been mentioned in the PM report. Time of death not mentioned in the Ex.P-54 and 55. Some colour changes after death. PM unity is not mentioned in Ex.P-54 and 55. Un digested food not mentioned in Ex.P-54 and 55. It is correct to suggest that injuries may be caused by using other than MO- 7 to 9. It is correct to suggest that this is first time I have seen the MO-7 to 9. It is not correct to suggest that I have issued Ex.P-54 and 55 request of Police.
