On 29.04.2026 Witness is present and duly Sworn:**Chief Examination by P.P:**

1. I have been working as Medical officer since September 2024 at General Hospital Harihar.

2. On 18.02.2025 at about 10.20 p.m, the injured namely Akshata Chandrappa Goneppanavar, Aged about 21 years R/o: Kodyal Hospet, Ranebennur came to hospital with alleged history of assault. Accordingly, I have examined the injured. On examination, I have noticed a small oral cavity wound measuring 1x1 cm.

3. The injured complained of body pain and also breathing problem. I have given first aid treatment to the injured. I have issued wound certificate to the effect that the said injury is simple in nature. I am now seeing the wound certificate and it is marked

as per Ex.P-8 and my signature is marked as Ex.P-8(a). The injury sustained by the injured and as mentioned on Ex.P-8 is simple in nature.

4. On the same day and same time, another injured namely Aishu Chandrappa Goneppanavar, Aged about 20 years R/o: Kodyal Hospet, Ranebennur came to hospital with alleged history of assault. Accordingly, I have examined the injured. On examination, I did not find any external injuries on the body of injured. But the patient complained of body pain.

5. Accordingly, I have issued wound certificate to the effect that the body pain is simple in nature. I am now seeing the wound certificate and it is marked as per Ex.P-9 and my signature is marked as Ex.P-9(a). The injury and body pain as mentioned on Ex.P-8 and 9 are possible if assaulted with hands and due to pull and push. Oral cavity as mentioned on Ex.P-8 is possible if assaulted with broken bricks.

Cross Examination by Sri. PCB advocate for accused No.1 to 7:

6. It is true to suggest that I did not bring MLC register maintained in our hospital to the Court to depose the evidence before the Court. It is true to suggest that I have not mentioned in my wound certificate vide Ex.P-8 and 9 as to who have assaulted on injured persons. It is also true to suggest that I have not mentioned in my wound certificates vide Ex.P-8 and 9 as to the nature of weapon of offence being used for commission of alleged offence.

7. It is true to suggest that oral cavity injury is possible during chewing of food. It is true to suggest that I did not suggest

further higher treatment to both the injured. It is true to suggest that the IO did not produce weapon of offence and also did not take any opinion with respect to weapon of offence. The IO had not produced any medical documents before me for reference.

8. It is not true to suggest that the injured did not come to our hospital. It is not true to suggest that I did not examined the any of the injured and not issued the wound certificates.
