1. I was working as Medical Officer at Ranebennur Government Hospital on deputation since January 2025 to August 2025.

2. On 20.06.2025 at about 2.45 p.m, the injured namely Pw-1-Guddappa Honnappa Olekar came to Ranebennur Government Hospital with history of assault on the same day at about 1.30 p.m. I have examined the injured Pw-1. On examination I did not found any external visible injuries on the body of Pw-1. Accordingly, I have issued wound certificate dtd:01.07.2025. I am now seeing wound certificate issued by me and it is marked as per Ex.P. 10 and my signature is marked as per Ex.P-10(a). Since I did not found any external injuries on the body of the Pw-1, I have not given any opinion.

3. On the same day, at about 2.45 p.m, another injured namely Pw-4-Govindappa Talawar came to Ranebennur Government Hospital with history of assault on the same day at about 1.30 p.m. I have examined the injured Pw-4. On examination I did not found any external visible injuries on the body of Pw-4. Accordingly, I have issued wound certificate dtd:01.07.2025. I am now seeing wound certificate issued by me and it is marked as per Ex.P.11 and my signature is marked as per Ex.P-11(a). Since I did not found any external injuries on the body of the Pw-4, I have not given any opinion.

4. On the same day, at about 2.45 p.m, another injured namely Pw-5-Chandrappa Hanumantappa Bannihatti came to Ranebennur Government Hospital with history of assault on the same day at about 1.30 p.m. I have examined the injured Pw-5. On examination I did not found any external visible injuries on the body of Pw-5. Accordingly, I have issued wound certificate dtd:01.07.2025. I am now seeing wound certificate issued by me and it is marked as per Ex.P.12 and my signature is marked as per Ex.P-12(a). Since I did not found any external injuries on the body of the Pw-5, I have not given any opinion.

5. External injuries may not be visible in case of assault with hands, push and pull and it depends up on force of assault and impact.

Cross Examination; by Sri. NGH Ld. advocate for accused:

6. It is true to suggest that I have not mentioned time of incident as 1.30 p.m. It is not true to suggest that I have not

examined Pw-1, 4 and 5 and not issued any wound certificates. It is true to suggest that I have not mentioned the identification marks of the Pw-1, 4 and 5. It is not true to suggest that I have issued false certificate and deposing false evidence before Court.
