**Application for Grant of Permanent Exemption of
accused/applicant Pardeep Kaur W/o Rajinder Singh.**

Present:- APP for the State.
Accused on bail with counsel Sh. N.S Romana Adv.

Order:

Heard on the application moved by counsel for accused for permanent exemption of accused Pardeep Kaur. Brief facts of the application are that Pardeep Kaur is facing this trial as an accused. Now, she is pregnant and she is expected to deliver a child in the later half of February or first half of March 2018. Due to her this medical position its almost impossible for her to travel from such a long distance and to reach this Hon'ble court at the third floor of judicial complex, Bathinda. Doctor/Gynecologist who is treating Pardeep Kaur has advised her rest. Hence prayer is made for allowing the application.

In view of the averments made in the application that accused Pardeep Kaur is pregnant and she is expected to deliver a child in the later half of February or first half of March 2018. Due to her this medical position its almost impossible for her to travel from such a long distance and as such she is unable to attend the court regularly. So, in view of the facts and circumstances of the case and in interest of justice, the personal appearance of the accused Pardeep Kaur is exempted till further orders,

but subject to furnishing the following conditions by way of filing affidavit by next date:

1. The counsel for the accused/applicant would appear on behalf of the accused and would be present when ever the case would be taken up.
2. The accused would not dispute his identity in the case.
3. Accused would come present at any date, when his personal appearance would be required by the court.
4. That the accused would undertake that he would have no objection if the evidence would be recorded in his absence and in the presence of his counsel.
