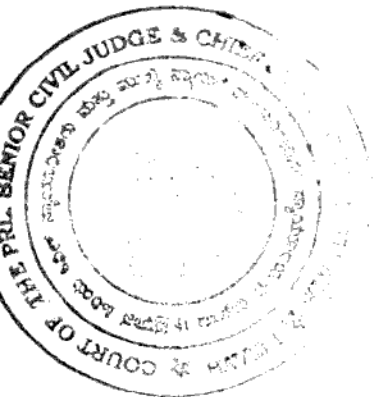
Plaintiff Prays:

- (A) A decree be drawn against defendants jointly and severally for Rs.6,02,334/- alongwith interest at the rate of 7% p.a compounded half yearly rests alongwith Overdue interest at the rate of 2% p.a. on the entire amount from the date of the suit to that of repayment and personal decree also be drawn.
- (B) In default of payment within the day to be fixed by the court directing the sale of suit schedule proeprty as mentioned under Order 34 Rule 6 of CPC.
- (C) Court cost be awarded.
- (D) Any other reliefs, as this Hon'ble Court may deemed fit and proper be awarded in the nature and circumstances of the case.

This suit is coming on this 01th July 2026 for final disposal before **Smt.Shobha B.G.**, I Additional Senior Civil Judge and J.M.F.C., Haveri in presence of Sri.V.K.Kelkar advocate for Plaintiff, Defendant No.1 to 3 are exparte. Accordingly it is hereby ordered and decreed that,

The suit of the plaintiff is hereby decreed with costs.

The defendants are jointly and severally liable to pay loan amount of Rs.6,02,334/- alongwith interest at the rate of 7% p.a. compounded half yearly rests on the principal amount from the date of the suit to till the decree. The defendants are also liable to pay penal interest at rate of 2% p.a., from the date of suit till its realization.
