-::CHARGE::-

I, Akarsh M. BA. LLM., Judicial Magistrate First Class,
Yelandur, do hereby charge you accused:

- 1) Nanjundashetty,
S/o late Madashetty,
Age: 45 years,
- 2) Shobha,
W/o Nanjunda @ Nanjundashetty,
Age: 35 years,
- 3) Manju @ Manjunatha,
S/o Mahadevashetty,
Age: 32 years,

All are R/o: Uttamballi Village,
Kollegala Taluk, Chamarajanagara Dist.

As hereunder:-

That on 15.05.2022 at about 04.30 P.M. within the limits of Mamballi Police Station at Uttamballi village, you accused nos.1 to 3 with the common intention of committing offence against CW1 & 2 (Gowramma & Jayamma), you accused no.1 has abused CW1 & 2 by saying “ಬಡ್ಡಿ ಸೂಳೇ ಏಕೆ ನನ್ನ ಮನೆಯ ಕಡೆಗೆ ನೀರು ಬಿಟ್ಟಿದಿಯಾ, ಲೇ ಬಡ್ಡಿ ಏನು ಮಾತನಾಡುತ್ತಿರಿ” as such you accused Nos.1 to 3 have committed an offence of intentional insult with an intent to provoke to commit the breach of public peace which is made punishable U/sec.504 R/w 34 of IPC and is within the cognizance of this Court.

Secondly, on the above said date, time & place you accused Nos.1 to 3 in furtherance of your aforesaid common intention, you accused no.2 has beaten CW1 by hands on her hands and body, you accused nos.1 & 3 have thrashed CW1 on her stomach and backside and caused simple injuries, as such you accused Nos.1 to 3 have committed an offence of voluntarily causing hurt which is made punishable U/sec.323 R/w 34 of IPC and is within the cognizance of this Court.

Lastly, on the above said date, time & place you accused Nos.1 to 3 in furtherance of the aforesaid common intention of committing offences against CW1 & 2, you accused No.1 has pulled the hair of CW1 and pushed her outside, when CW2 came to spot to pacify the quarrel at that time you accused no.3 has pulled the nighty and vale

with an intention to outrage their modesty, as such you accused Nos.1 to 3 have committed an offence of assault or criminal force to woman with intent to outrage her modesty which is made punishable U/sec.354 R/w 34 of IPC and is within the cognizance of this Court.
