

Witness recalled and duly sworn on : 13-02-2019

Cross examination by BSA counsel for defendant :

Since 20 years I am indulged in crafting/nursery. Till today I am growing saplings in nursery. I am running nursery in name and style of Vanasiri Nursery. It is not so much publicized. I have not obtained any permission from concerned department to run nursery. I have not issued any bills for having sold saplings to anybody. I used to supply saplings of mango, chickoo, gulabi, sampige etc., Might be 10 years ago I have supplied saplings to plaintiff. Now I could not recollect exact date and year. I have not maintained any register to show sale and production of saplings in nursery. I could not say exactly in which year I have supplied saplings to plaintiff. I have supplied samplings to Ambajanna who is resident of Hangal. I could not recollect as to whether I have supplied saplings to residents of Gejjihalli other than present plaintiff.

2. I know the contents of my examination-in-chief. Suit property is situated to west of Gejjihalli. I could not

say properties of other persons which are situated adjacent to suit property. Now I could not say exactly how many saplings I had supplied to plaintiffs. I alone had been to suit property when saplings were supplied to plaintiff. After planting of saplings in suit property I have not visited the property of plaintiff so as to ascertain what is the growth of saplings. It is not true to suggest that, I have not supplied any mango saplings to plaintiff. I could not recollect as to whether any crop grown in neighboring land of suit property when I had visited property of plaintiff. It is not true to suggest that, at no point of time I had been to suit property so as to plant saplings. It is not true to suggest that, plaintiff never purchased any saplings from my nursery. The plaintiff used to attend coolie work in area situated near by my village. There is nearly 10 to 12 kms distance in between cheeranahalli and Gejjihalli. It is true I am landlord of Cheeranahalli. It is true I owned so many landed properties earlier I used to engage coolies to carry out agriculture work. Now I am not doing any

agriculture work. It is true plaintiff and his sons might have attended coolie work in my landed properties. Villagers of Gejjihalli even today are attending coolie work in my landed properties. It is not true to suggest that, since lifetime of my father, we know the plaintiff. It is not true to suggest that, as plaintiff has attended coolie work in my landed properties, just to help him I am falsely deposing I had supplied mango saplings to plaintiff. It is not true to suggest that, plaintiff has not planted any mango saplings in suit property as deposed by me. It is not true to suggest that, just to help the plaintiff I am deposing false evidence.
