5. The Applicant states that the Applicant will not abscond and tamper with the evidence.

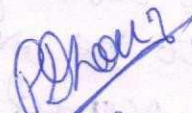
6. The Applicant states that the applicant is being attempted to be falsely implicated in the alleged offence and that the Applicant is innocent.

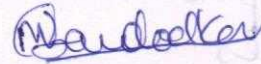

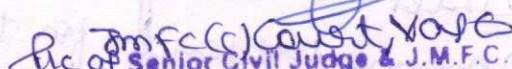

perused the contents of the application and the say of J.O. The J.O. has prayed for Judicial Custody. Initially the accused was not produced with the bail application as he was admitted in hospital.

As of now accused is produced after being discharge. Accused is ready to furnish surety and abide with the conditions. There is no ground made out by the J.O. to detain the accused in judicial custody. Therefore I am of the view that accused is entitled to be release on bail upon following conditions:

- 1) Accused shall be released if not required in any other crime upon executing personal bond of Rs 10,000 and local surety in like amount to the satisfaction of J.O./P.E. of Verna P.S.
- 2) Accused and surety shall furnish their detail address with photo identity proof to the J.O. along with their phone numbers and J.O. shall verify the details.
- 3) Accused shall not interfere with the complainant and shall not visit the scene of offence for the period of 8 days after release.
- 4) Accused shall not tamper with the evidence and shall remain present for trial whenever charge sheet is filed.
- 5) Accused shall not leave the state without prior permission of the court pronounced in open court.
