This complaint has been filed by a public servant Sh. Manoj Nanwal, IO in discharge of his duties. He has moved an application for dispensing with his preliminary examination and for his exemption from personal appearance for future dates on the ground that he remains busy in official duties and it is not possible for him to attend the court on each and every date of hearing and that he be therefore allowed to be represented through the Special PP. In view of the submissions made, the preliminary examination of the complainant is dispensed with and he is exempted from personal appearance during trial

Perused the complaint.

Brief facts of the case are that on the basis of secret information raid was conducted at M/s Calyx Biotech Shop No. 211 Second Floor, SG Shopping Complex, Rohini, Delhi and from the said premises there is recovery of 50 ampules of pentazocine injection, 144 + 720 tramadol capsules, these medicines were in condition to be dispatched without any

prescription and bill. From the shop no. 306, III Rd floor, SG shopping mall there is further recovery of 1200 + 1200 ampules of pentazocine injection from delivery boy Raju Kumar who came to deliver the said contraband to the accused Sarvan and from shop no. 306 there is further recovery of 700 ampules of tramadol, 480 + 280 capsules of tramadol and 1900 tablets of tapentadol tablets, the licence of abovesaid shop no. 211 in the name of Sarvan then the accused was apprehended and he disclosed about godown and basement of house of Vinod Yadav *Peeples* Chowk Rajapur, Rohini and from the said godown there is recovery of commercial quantity of alprazolam, tramadol, codeine phosphate. FSL result is positive for tramadol hydrochloride, alprazolam, codeine phosphate, tapentadol hydrochloride and pentazocine. Accused Sarvan was running whole syndicate with Sandeep (not arrested yet) firm with the name of Ganesh Pharma, therefore, on the basis of documents filed alongwith complaint and complaint, undersigned takes cognizance of the offence punishable u/s 21, 22 & 29 NDPS Act.

Issue production warrants for accused for next date.
