	14.08.26	A petition for surrender and bail along with xerox copy of documents has been filed on behalf of the accused-petitioners namely, Suresh Kumar Bauri. A joint compromise petition and permission petition has been filed on behalf of both the parties. A copy of the same has been served to the ld. cl. of the complainant. Another petition to recall the date has been on behalf of the accused. In this case both the parties have compromised this case, hence, in the interest of justice, the date is hereby recalled and fixed today. Case called out. The accused-petitioner appeared with his ld. counsel and petitioner are taken into judicial custody. The ld. cl. of the complainant along with complainant is also present before the court. <i>The Charge u/s 498A of IPC has been framed against the accused-petitioner and the contents of the charge has been read over and explained to the accused-petitioner in Hindi, to which he pleaded not guilty and claimed to be tried.</i> The ld. counsel of the accused-petitioner has submitted that earlier the petitioner was all along on bail and on 29.01.2025 the record was fixed for framing of Charge, the petitioner was not physically present before the court rather a petition u/s 317 of Cr.P.C. has been filed on his behalf, instead of direction of the court, consequently, his bail has been canceled v.o.d. 29.01.2025, and NBW was issued against him. There is no deliberate mistake by him, and he undertakes to be vigilant in taking steps and to be in appearance in future on each and every date. He further submitted that both the parties have compromised this case and also filed a joint compromise petition. It has been therefore, prayed to release the petitioner on bail. On the other hand the ld. cl. of the complainant has conceded the factum of compromise. Having consideration to the submission, it is quite evident from perusal	

Contd.. 14.08.26 (Later on) 14.08.26	of the order sheet that the bail of the accused-petitioner has been canceled on 29.01.2025, when the record was fixed for charge. Today, the accused-petitioner has voluntarily surrendered before the court and the Charge has already been framed against the accused-petitioner and both the parties have compromised this case and also filed a Joint Compromise Petition and permission petition to compromise this case. He undertakes to be vigilant in the pairvi in future and will remain in appearance in future in this case. This is a case of misuse and he is ready to follow the terms and conditions of compromise/settlement. So, considering the facts and circumstances as discussed above, the accused-petitioner is hereby granted Bail on his furnishing bail bond of Rs.10,000/- with one surety of the like amount each, with condition that the petitioner will strictly follow the terms and conditions of compromise/settlement and he will remain physically present before the court on 21.08.2026. . (Dictated). Sd/- C.J.M. As per the above order, required bail bond has been furnished from aforesaid accused-petitioner, which has checked and found in order, hence, accepted and the accused-petitioner is released from custody.
