COMMITTAL ORDER U/SEC.232 of BNSS

The CPI of Hangal Circle has filed a charge sheet against the accused No.1 to 4 for the offences P/U/Ss.115(2), 118(1), 109, 351(2), 352 R/w 3(5) of BNS. On 09-06-2026 this Court took cognizance of aforesaid offences P/U/Ss.115(2), 118(1), 109, 351(2), 352 R/w 3(5) of BNS.

2. On perusal of materials available on record and on hearing the learned APP and the counsel for the defense, it is clear that, aforesaid alleged offence U/s.109 of BNS is exclusively triable by the Hon'ble District and Session Court, Haveri. Therefore, it is essential to commit the case to the Hon'ble Prl. District and Sessions Court, Haveri as contemplated U/s.232 of BNSS.

3. Accused No.1 to 4 are on bail. The accused persons have been supplied with prosecution papers as contemplated U/Sec.230 of BNSS. To secure the attendance of the accused No.1 to 4 before the Hon'ble Prl. District and Sessions Court, Haveri, it is necessary to obtain security from them for their appearance. Accordingly, committal surety has been obtained. As a result, this court has proceeded to pass the following:-



ORDER

***Criminal case in
C.C.No.319/2026 is hereby committed
to Hon'ble Prl. District and Sessions
Judge, Haveri and the accused No.1 to
4 are hereby directed to execute a
bond of Rs.1,00,000/- each and with
one surety for likesum. Further, the
accused No.1 to 4 are directed to
appear before the Hon'ble Prl. District
and Sessions Judge, Haveri on the
date called upon by it.***

order of committal to the prosecution
and send all the case papers,
documents and articles if any related
to the case to the Hon'ble Prl. District
and Sessions Judge, Haveri forthwith.***
