FINAL ORDER

(Delivered on this the 30th day of the month of September
of the year 2023)

The present Inventory Proceedings have been
instituted by Deepak Balkrishna Kaisare, aged 62 years,
married, business, resident of H. No.41/10, Panditwada,
Curti, Ponda, Goa upon the death of his parents namely,
Balkrishna Manguesh Kaissore and Leelabai Balkrishna
Sinai Kaisare, wherein Deepak Balkrishna Kaisare is
appointed as the Head of the Family vide order dated
20/10/2022.

2. As per the Declaration on oath given by the
Head of the Family, the estate leavers Balkrishna
Manguesh Kaissore and Leelabai Balkrishna Sinai Kaisare

died on 02/09/1977 and 11/07/1995 respectively, leaving behind their following children as their sole and universal heirs namely:

(iv) Shri. Deepak Balkrishna Kaisare married to Smt. Hema Deepak Kaisare; and

(v) Shri. Naresh Balkrishna Kaisare, major of age, unmarried.

It is stated that besides the above heirs, the deceased have not left any other heir, nor any creditors or legatees who can claim the inheritance of said deceased persons.

3. The Final List of Assets is drawn at exhibit A/14.

4. The Chart of Partition dated 10/08/2023 at exhibit A/16 is hereby confirmed and made absolute and consequently the shares stand allotted to the Head of the Family and respective Interested Parties in the present inventory proceedings instituted upon the death of the above named deceased wherein Deepak Balkrishna Kaisare was appointed as the Head of the Family.
