This petition came before this Tribunal on this day for final settlement during this Lok Adalat in the presence of the petitioners, their counsel Sri G. Siva Prasad Reddy, Advocate and Respondent No.2 and it's counsel Sri P. Venkateswarlu.

Both parties to the petition have agreed for amicable settlement and filed terms of settlement with free will and volition. Hence, the following award is passed as per the settlement arrived by the parties.

AWARD U/s. 21 OF THE LEGAL SERVICES AUTHORITY ACT, 1987.

Both parties are present. The claimants and Respondent No.2 settled the matter before Lok Adalat.

2. The Claimants and the Respondent No.2 have settled the claim at **Rs.9,30,000/-** (Rupees nine lakhs and thirty thousand only) towards full and final settlement.

Apportionment is as follows:

3) Out of the settled amount, the Insurance Company (R2) shall deposit the amount of Rs.5,00,000/- in favour of 1st petitioner and Rs.4,30,000/- in favor of the 2nd petitioner in any Nationalized Bank. Both the Petitioners are entitled to receive the entire amount at once. The Respondent No.2 is directed to issue cheque directly in favour of the Petitioners 1 and 2 for their respective amounts.

Interest:-

4. The insurance company (R2) is agreed to deposit the settled amount within two months from today, failing which, it shall bear interest at 6 % p.a from the date of petition.

Refund:-

5. Claimant is entitled to refund of court fee, if any.

Hence, the Award.
