JUDGMENT:-

1. Present complaint under Section 208 of Haryana
Municipal Act 1973 was filed by complainant against the
accused on 4.10.2022.

2. Brief facts, as alleged in the complaint is that

the accused raised construction of building without any prior permission of the Municipal Committee, Kaithal and did not demolish the said construction made by his on house even after having been served upon him a notice by the Secretary, Municipal Committee, Kaithal and the accused has committed the offences punishable under section 208 of Haryana Municipal Act, 1973.

3. Matter was taken up in today's National Lok Adalat. As the accused showed his willingness to confess his guilt, he was made understood that he was not bound to make any confessional statement and any statement given by him may be used against him. But he was determined to confess his guilt and accordingly he pleaded guilty. His confessional statement recorded. As the accused has confessed his guilt, he is hereby held guilty for commission of offence punishable under section 208 of Haryana Municipal Act, 1973. The accused is hereby sentenced to pay a fine Rs.5000/- for commission an offence punishable under Section 208 of Haryana Municipal Act and in default of payment of fine, convict shall undergo simple imprisonment for 15 days. Fine has

been paid. Receipt Issued. Accused be set at liberty. File
be consigned to the record-room after due compliance.
