COMMITTAL ORDER

The PSI, Savanur Police Station, has filed the charge sheet against the accused persons for the offences punishable under Section 114, 323, 341, 504, 506 r/w 34 of IPC.

2. This Court had taken cognizance of the said offences and registered the above criminal case. During the course of trial, the learned Assistant Public Prosecutor filed an application



under Section 323 of Cr.P.C. seeking committal of the case to the Hon'ble Sessions Court on the ground that the evidence of PW-1 prima facie discloses the commission of an offence punishable under Section 307 of IPC, which is exclusively triable by the Court of Sessions. The learned counsel appearing for the accused persons filed objection.

3. After hearing both sides, this Court, by a separate order, has allowed the application filed under Section 323 of Cr.P.C. and held that the materials available on record prima facie disclose the commission of an offence punishable under Section 307 of IPC.

4. The accused persons are on bail and furnished the committal surety. In view of the said order, the offence now disclosed is exclusively triable by the Court of Sessions. Therefore, this Court has no jurisdiction to proceed with the trial of the case. Accordingly, the case is liable to be committed to the Hon'ble District and Sessions Court, Haveri, for trial. Accordingly, this court proceed to pass the following;

ORDER

Acting under Section 209 of Cr.P.C, the case is hereby committed to the Hon'ble District and Sessions Court, Haveri, for trial.



The office is directed to prepare the committal records, arrange the entire case papers with proper index, and forthwith transmit all original records, documents, material objects, if any, and the committal proceedings to the Hon'ble District and Sessions Court, Haveri, for further proceedings.

Office is directed to Issue intimation to Learned Public Prosecutor of the Hon'ble Prl. District and Sessions Judge Court, Haveri, regarding committal of this case.

The Accused Persons are directed to appear before the Hon'ble District and Sessions Court, Haveri, after receiving intimation or summons or notices without fail.
