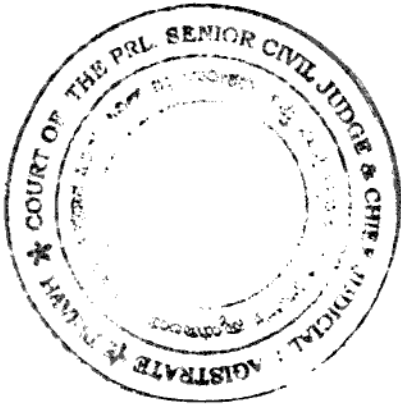

The petition filed by the petitioner U/Sec 166 of Motor Vehicle Act, 1988, is allowed in part with costs.

Petitioner is entitled for compensation of Rs.1,68,000/- (Rupees One Lakh Sixty Eight Thousand Only) along with interest at the rate of 6% p.a. from the date of petition till the date of deposit in the tribunal.

The Respondent No .1 owner and Respondent No.2 Insurer are jointly and severally liable to pay compensation amount to the petitioner.

The respondent No.2 is directed to indemnify the said compensation and directed to deposit the compensation amount with accrued interest within 60 days from the date of this order.

The respondent No.2 is at liberty to recover said compensation amount from respondent No.1 in accordance with law as per principle of pay and recover.

Since compensation amount is meager, on deposit of the compensation amount, entire amount shall be released in the name of petitioner appearing in the award in accordance with law.



The Advocate's fee is fixed at Rs.2,000/-.
