It neither changes the nature and character of the defence or the counter claim nor introduces any new plea. The proposed amendment does not prejudice the plaintiff/opposite party and appears necessary for the proper adjudication of the dispute. The objection regarding the drafting of the petition is technical in nature and, in the absence of any objection to the proposed amendment on merits, is not sufficient to reject the prayer. 6. Accordingly, the present Misc. (J) Case is allowed on payment of cost of Rs. 500/- by the defendant No. 1/petitioner to the plaintiff/opposite party. 7.
