

Misc. Crl. Applications No. 1669/2022, 1672/2022, 1679/2022 and 1681/2022

(Rikhiya P.S. Case No. 239/2022)

Four separate surrender cum bail petition along with fresh Vakalatnama has been filed on behalf of the accused/petitioners namely **Dibesh Kumar Singh, Dashrath Pasi @ Dashrath Kumar Mahtha, Sanjay Kumar, Niraj Kumar Singh, Sushil Kumar Singh** and **Sushil Kumar Singh** through their learned lawyer. Copy of the same has been served upon the learned A.P.P.

The learned lawyer of the petitioners has submitted that the petitioners are quite innocent and have not committed any offence under law. The petitioners have not filed any bail petition before any superior court prior to this one. The accused/petitioners have been implicated in the instant case with a view to harass him. The petitioners have already deposited loss amount to the Electricity Department. It is, therefore, prayed that the accused/petitioners may kindly be released on bail.

Heard and perused the case record. On perusal, it transpires that the instant F.I.R. has been lodged as Rikhiya P.S. Case No. 239/2022, U/s 135 of the Indian Electricity Act on the basis of the written report of the informant Bhashkar Vinita, J.E.E., Electricity Department, Deoghar. Alleged sections against the accused/petitioners are non-bailable but compoundable in nature and petitioners namely **Dibesh Kumar Singh** has already deposited dues amount of Rs 510/- vide receipt no. 6311200014853 dt. 13.10.2022 and fine amount of Rs 43,780/- vide receipt no. 372673 dt. 13.10.2022, **Dashrath Pasi @ Dashrath Kumar Mahtha** has already deposited dues amount of Rs 1,000/- vide receipt no. 6311100007292 dt. 12.10.2022 and fine amount of Rs 21,890/- vide receipt no. 372682 dt. 12.10.2022, **Sanjay Kumar** has already deposited dues amount of Rs 720/- vide receipt no. 6311200014858 dt. 12.10.2022 and fine amount of Rs 43,780/- vide receipt no. 372680 dt. 12.10.2022, **Niraj Kumar Singh** has already deposited dues amount of Rs 1600/- vide receipt no. 6311100007283 dt. 12.10.2022 and fine amount of Rs 65,670/- vide receipt no. 372677 dt. 12.10.2022, **Sushil Kumar Singh** has already deposited dues amount of Rs 1,150/- vide receipt no. 6311200014870 dt. 11.10.2022 and fine amount of Rs 43,780/- vide receipt no. 3572681 dt. 11.10.2022 and **Sushil Kumar Singh** has already deposited fine amount of Rs 65,670/- vide receipt no. 72639 dt. 14.10.2022 and they have received no dues certificate from the Electricity Department. The petitioners have shown original receipt and no dues certificate and submitted xerox copy of document. Hence, the above named accused/petitioners are directed to be enlarged on bail on his furnishing bail bond of Rs 5,000/- with one surety of like amount each.
