C H A R G E

I, Smt. Suman Chittargi B.Com., LL.M., Prl. Civil Judge & JMFC, Aland, do hereby charge you:

Aged: 30 years, Occ: Kirana Shop,
R/at Mataki Road, Aland.
2. Ashwath S/o Arjunrao Kalekar,
Aged: 37 years, Occ: Gold Shop,
R/at Kotti Galli, Aland.
3. Santosh S/o Jayaprakash Kumbar,
Aged: 47 years, Occ: Business,
R/at Kumbar Galli, Aland.
4. Shivanand @ Shiva S/o Channamallappa Yelasangi,
Aged: 40 years, Occ: Working at Corporation,
R/at Kumbar Galli, Aland,

As follows:

That you accused No.1 to 4 on 15.09.2024 at about 07:50 pm when the CW-1 and 4 to 9 were working in the cloth centre which comes within the limits of Aland P.S at that time accused No.1 to 3 having dispute with regard to existence of common wall between the houses of CW-1 and accused No.1 and 2, came over there infurtherance of common intention picked up quarrel with the CW-1 wrongfully restrained the movement of CW-1 from moving in a direction with an intention to commit certain offences and thereby you have committed an offence punishable U/Sec.126(2) R/w Sec.3(5) of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 4 infurtherance of your common intention picked up quarrel with CW-1 and voluntarily assaulted with Chappal to the CW-1 on his left chest and right cheek with an intention to dishonor him in the society and thereby you have committed an offence punishable U/Sec.133 R/w Sec.3(5) of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 4 infurtherance of your common intention picked up quarrel with CW-1 and voluntarily assaulted with bare hands dragged him by holding his T-Shirt and thereby caused internal injury to him and thereby you have committed an offence punishable U/Sec.115(2) R/w Sec.3(5) of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 4 infurtherance of your common intention picked up quarrel with CW-1 in connection with existing between house of

you accused No.1 and 2 and the CW-1 at that time you accused No.3 encouraged the accused No.1 and 2 to commit such offences by way of abatement and thereby you have committed an offence punishable U/Sec.49 R/w Sec.3(5) of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 4 infurtherance of your common intention picked up quarrel with CW-1, you accused No.1 abused the CW-1 as " ಏ ಬೋಸಡಿ ಮಕ್ಕಳಿ ನಿಮ್ಮದು ಬಹಳ ಆಗಿದೆ" provoked him intending that such provocation would cause him to break the public peace and thereby you have committed an offence punishable U/Sec.352 R/w Sec.3(5) of BNS, within the cognizance of this Court.

That on the above said date, time and place, you accused No.1 to 4 infurtherance of your common intention picked up quarrel with CW-1 and threatened him with dire consequences so as to cause alarm in his mind by committing an act of criminal intimidation and thereby you have committed an offence punishable U/Sec.351(2) R/w Sec.3(5) of BNS, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
