The State through Nimbarga P.S.-V/s. – Shivaputra and Others.

CHARGE

*I, **Yallappa Kallapur**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Shivaputra S/o. Basanna Balurgi,
Aged: 50 years, Occ: Agriculture,
2. Shantabai W/o. Shivaputra Balurgi,
Aged: 45 years, Occ: Agri. & Household,
3. Savitha W/o. Mallappa Balurgi,
Aged: 28 years, Occ: Agri. & Household,

Above all are R/o. Yalasangli Village, Tq: Aland

As follows;

Firstly, that on 13.08.2019 at 11:45 a.m. on boundary of Madiyal Village in land Sy.No.60, within the limits of Nimbarga Police Station, when CW1 and CW4 were plucking the grass on bandara, you, accused No.1 came there in furtherance of common intention, you accused No.1 intentionally insulted CW4 by abusing him in filthy language stated that “ಏ ಬೋಸಡಿ ಮಗನೆ ಬಂದಾರಿ ಮೇಲಿನ ಹುಲ್ಲು ಯಾಕ ಕಿತ್ತತಿ ” when CW4 asked as on the above and you, accused No.1 further abused him in filthy language stating that “ಏ ರಂಡಿ ಮಗನಾ ನಾ

ಹೇಳಿದ್ದು ನೀ ಯಾವಾಗನೂ ಕೇಳಿಲ್ಲಾ ಇವತ್ತುನು ಕೇಳಂಗಿಲ್ಲ ನಿನ್ನದು ಬಹಳ ಆಗ್ಯಾದ,” when CW1 came to pacify the quarrel, you accused No.1 intentionally insulted CW1 by abusing her in filthy language stating that “ ಕ್ಷ ರಂಡಿಗೂ ಬಹಳ ಆಗ್ಯಾದ,” you accused No.2 intentionally insulted CW1 by abusing her in filthy language stating that “ ಏ ರಂಡಿ,” and you accused No.3 came there and intentionally insulted CW1 by abusing her in filthy language stating that “ ಈ ರಂಡಿದೂ ಬಹಳ ಆಗ್ಯಾದ” and gave provocation to them intending or knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Secondly, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you, the accused No.1 assaulted CW4 with a stone on his back and right leg thigh and you, accused No.2 assaulted CW1 with a [ಋಠಃ] on her head and caused bleeding injury and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Thirdly, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you accused No.1 pulled the saree and heirs of CW1, a woman intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you have committed an offence punishable U/Sec.354

R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Fourthly, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you, the accused No.1 knocked down her and slapped CW1 and assaulted CW1 on her back, when CW1 and CW4 were escaping on there, you accused No.3 assaulted CW1 on her back with hands and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Fifthly, that on the above said date, time and place, in furtherance of the above offence and in furtherance of common intention, you, the accused No.2 wrongfully restrained CW1 the movement of CW1 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Finally, that on the above said date, time and place, in furtherance of the above offence and in furtherance of common intention, you accused No.1 to 3 criminally intimidated CW1 and CW4 by threatening to take away them life “ ಏ ರಂಡಿ ಮಕ್ಕಳ್ಯಾ ನಿಮ್ಮದು ಬಳ ಆಗ್ಯಾದ ಇವತ್ತು ನಿಮಗೆ ಜೀವ ಸಹಿತ ಬಿಡಂಗಿಲ್ಲ ಖಲಾಸ ಮಾಡುತ್ತೇವೆ” so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

And I hereby direct that you be tried on the said charge.
