Aland, do hereby charge you,*

Aged: 25 years, Occ: Coolie,
R/o. Shakapur Padri Tanda, Taluka Aland.
3. Kalyani @ Kalya S/o. Bhagu @ Bhagavant Chawan,
Aged: 35 years, Occ: Agriculture,
R/o. Kamasur Nayak Tanda, Taluka Aland.
4. Ramaji S/o. Jakalu Kale,
Aged: 50 years, Occ: Coolie,
R/o. Shakapur Padri Tanda, Taluka Aland.
5. Begum D/o. Ramaji Kale,
Aged: 50 years, Occ: Agriculture,
R/o. Shakapur Padri Tanda, Taluka Aland.

As follows;

Firstly, that on 25.12.2019 at 2:00 p.m. at Yadgir Colony at Aland Town, within the limits of Aland police station, in furtherance of common intention of you accused

No.1 to 5, have broken the door lock of the house of CW1 and entered into the said house and thereby you have committed an offence punishable U/Sec.454 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 5, have committed theft of articles i.e. 10 Grams of Golden Locket, 35 Grams of (ಹೆಣ್ಣು ಮಕ್ಕಳ) Gantana, 5 Grams of two Golden rings, 03 Grams of two (ಹೆಣ್ಣು ಮಕ್ಕಳ) rings, 04 Grams 01 Ring, 10 grams of (ಹೆಣ್ಣು ಮಕ್ಕಳ) Flower Mati, 10 Grams of (ಹೆಣ್ಣು ಮಕ್ಕಳ) ear ring and Cash of Rs.1,05,000/- and thereby you have committed an offence punishable U/Sec.380 of Indian Penal Code, within my cognizance.

And I hereby direct that you be tried on the said charge by this Court.
