**C H A R G E**

*I, SNEHA PATIL., Addl. Civil Judge & JMFC, Aland, do hereby charge you, as follows;*

Firstly, on 20.05.2020 at 6:30 p.m. at Kinni Abbas village, in the Government School, within the limits of Madan Hipparga Police Station, when CW1 came to quarantine center for under going quarantine the CW4, you accused No.1 used criminal force on CW1 with an intention to prevent or deter and discharg her duty as a public servant and thereby you accused No.1 to 5 in prosecution of common object have committed an offence punishable U/Sec.353

R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Secondly, that on above said date, time and place, you the accused No.1 wrongfully restrained CW1 from proceeding in any direction and thereby you accused No.1 to 5 in prosecution of common object have committed an offence punishable U/Sec.341 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Thirdly, that on above said date, time and place, you accused No.1 abused CW1 in filthy language, intending or knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you accused No.1 to 5 in prosecution of common object have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Fourthly, that on above said date, time and place, you accused No.1 used criminal force against CW1 a woman, pulled the left hand of CW1, intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you accused No.1 to 5 in prosecution of common object have committed an offence punishable U/Sec.354 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Fifthly, that on above said date, time and place, you accused No.1 turned the hand of CW1 and thereby you accused No.1 to 5 in prosecution of common object have committed an offence

punishable U/Sec.323 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Sixthly, that on above said date, time and place, you accused No.2 to 5 voluntary caused hurt to CW1 with a stone on her chest and also other parts and she fell down, if which is used as weapon of offence is likely to cause death and thereby you accused No.1 to 5 in prosecution of common object have committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Seventhly, that on the above said date, time and place, you accused No.2 to 5 voluntarily caused hurt to CW1 with a stone, if which is used as a weapon of offence is likely to be caused death and thereby you accused No.1 to 5 in prosecution of common object have committed an offence punishable U/Sec.326 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Eighthly, that on above said date, time and place, you accused No.1 as acted negligently which is likely to spread infection of disease Covid-19 dangerous to life and thereby you accused No.1 to 5 in prosecution of common object have committed an offence punishable U/Sec.269 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.

Lastly, that on above said date, time and place, you accused No.1 has acted malignantly which is likely to spread the infection disease Covid-19 dangerous to life and thereby you accused No.1 to 5 in prosecution of common object have committed an offence

punishable U/Sec.270 R/w Sec.149 of Indian Penal Code and the same is within the cognizance of this Court.
