COMMITTAL ORDER

The PI of Aland PS has filed charge sheet against accused No.1 to 3 and same has been registered as C.C.No.64/2026 for the offences U/Secs.352, 351(2), 115(2), 118(2), 109 R/w Sec.3(5) of BNS.

2. After filing of the Charge Sheet, since there are sufficient material to proceed against accused No.1 to 3. Cognizance for the above said offences were taken.

3. Accused No.1 and 2 were got enlarged on bail, as per the order of Hon'ble I Addl. Dist: & Sessions Judge, Kalabruagi in Crl. Misc.No.1663/2025 dated: 18th October – 2025 and accused No.3 was got enlarged on bail, as per the order of I Addl. Dist: & Sessions Judge, Kalabruagi in Crl. Misc.No.1756/2025 dated: 31.10.2025.

4. On perusal of the Charge Sheet, it is clear that, the Investigation Officer has submitted entire case papers relating to this case. One of the offence punishable U/Sec.109 of BNS against the accused persons is exclusively triable by the



Hon'ble Court of Sessions. On considering the facts and circumstances of the case, case papers and statement of the accused persons at this stage, there are sufficient materials to prove the guilty of the accused persons, but this court has no jurisdiction to try the case. Hence, this is a fit case for committal to the Hon'ble Sessions Judge, Kalaburagi for further trial. Hence, I proceed to pass the following:

ORDER

Case stands Committed under section 232 of BNSS to the Hon'ble Prl. District and Sessions Court, Kalaburagi.

The accused No.1 to 3 are hereby directed to execute personal bond for Rs.50,000/-each with a surety for like-sum.

Prosecution papers as required under section 231 of BNSS furnished to the accused persons.

Notify the Public prosecutor about committal order.

Office is hereby directed to send the entire case papers to Hon'ble Prl. District



and Sessions Judge, Kalaburagi with properties.

The accused No.1 to 3 are hereby directed appear before the Hon'ble Court of Sessions soon after receipt of summons.
