C H A R G E

I, YALLAPPA KALLAPUR, Prl. Civil Judge & JMFC Aland, do hereby charge you,

ACCUSED:

Pradeep S/o. Mallanna Manga,
Aged:26 years, Occ: B.P.M. Bennishiroor,
R/o. Nelogi village, Taluka Jewargi.

As follows;

Firstly, that you accused was on duty between 09.03.2010 to 29.12.2010, being a Grameen Daka Sevak [ಗ್ರಾಮೀಣ ಡಾಕ ಸೇವಕ] at Bennishiroor Post Office at Bennishiroor village, within the limits of Nimbarga Police Station, have illegally withdrawn the money from the R.D. account of CW4 bearing account No.208382 1] Rs.200/- on 18.09.2010, 2] Rs.200/- on 25.10.2010, 3] Rs.200/- on 22.11.2010, 4] Rs.200/- on 07.12.2010 total amount of Rs.800/-, from the account of CW5 R.D. account No.207939 1] Rs.600/- on 18.10.2010, from the account of CW6 R.D. account No.20824 Rs.1,000/- on 22.09.2010, Rs.1,000/- on 27.10.2010, Rs.1,000/- on 29.11.2010, from the account of CW7 R.D. account No.207632 Rs.500/- on 30.05.2010, Rs.500/- on 30.07.2010, Rs.1,500/- on 09.10.2010, Rs.500/- on 12.11.2010, Rs.500/- on 18.12.2010,

from the account of CW8 R.D. account No.207704 Rs.200/- on 24.06.2010, Rs.100/- on 22.07.2010, Rs.100/- on 18.08.2010, Rs.100/- on 17.09.2010, Rs.100/- on 18.10.2010, Rs.200/- on 14.12.2010 and from the account of CW9 R.D. account No.207613 1] Rs.100/- on 15.04.2010, 2] Rs.100/- on 15.05.2010, 3] Rs.100/- on 17.06.2010, 4] Rs.100/- on 19.07.2010, 5] Rs.100/- on 20.08.2010, 6] Rs.100/- on 21.09.2010, 7] Rs.100/- on 26.10.2010, 8] Rs.100/- on 22.12.2010, total withdrawn amount of Rs.9,600/- from the above said R.D. Account holders, having common intention of cheating to the government/ R.D. Account holders and thereby you have committed an offence punishable under Section 420 of Indian Penal Code, within the cognizance of this court.

Finally, that during the above said period and place, you accused being the employee of the said Post Office, have received above said money from their R.D. Accounts and committed criminal breach of trust and thereby you have committed an offence punishable under Section 409 of Indian Penal Code, within the cognizance of this court.

And I hereby direct that you be tried by this court on the said charge.
