C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Ashok S/o. Shrimanth Itambale,
Aged: 28 years, Occ: Business,
2. Rajkumar S/o. Shrimanth Itambale,
Aged: 32 years, Occ: Business,
3. Daulapppa S/o. Shrimanth Itambale,
Aged: 34 years, Occ: Business,
4. Datta S/o. Pandurang Hibare,
Aged: 45 years,

Above all are R/o. Sultanpur Galli, Tq: Aland.

As follows;

Firstly, that on 28.11.2015 at 5:00 p.m. in Sultanpur Galli, at Aland Town, within the limits of Aland Police Station, in furtherance of your common intention of you accused No.1 to 4, have wrongfully restrained the movement of CW1 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Secondly, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you accused No.1 to 4 intentionally insulted CW1 by abusing her in filthy language as “ರಂಡಿ ಭೊಸಡಿ” and further abused her in filthy language stating that “ರಂಡಿರಾ ನೀವು ಮನೆಯ ಹೊರಗಡೆ ಬನ್ನಿರಿ ನಿಮ್ಮ ಕಾಲುಗಳು ಕಡೆಯುತ್ತೇವೆ” and thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause CW1 to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Thirdly, that on the above said date, time and place, in furtherance of above offence and in prosecution of common intention, you accused No.1 to 4 voluntarily caused hurt to CW1 with hands and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Finally, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 4, have criminally intimidated CW1 by threatening to take away her life, so as to cause alarm in her mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

And I hereby direct that you be tried on the said charge.
