CHARGE

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Kallappa S/o. Amrutappa Sarasambi,
Aged: 54 years, Occ: Agriculture,
 2. Amrutappa S/o. Chandappa Sarasambi,
Aged: 42 years, Occ: Agriculture,
 3. Sharanabasappa S/o. Kallappa Sarasambi,
Aged: 32 years, Occ: Agriculture,
- Above all are R/o. Hittal Shiroor village, Tq: Aland.

As follows;

Firstly, that on 23.01.2017 at 5:00 p.m. at Hittal Shiroor village, within the limits of Nimbarga Police Station, you accused No.1 to 3 in furtherance of common intention of the dispute between the wall, when CW4 and you accused No.1 were quarreling each other, CW1 came to pacify quarrel, at that time you accused No.1 intentionally insulted by abusing CW1 in filthy language stating as “ಏ ರಂಡಿ ನಿನಗು ಜಗಳಕ್ಕೂ ಸಂಬಂಧ ಇಲ್ಲ ಯಾಕೆ ಸುಮ್ಮನೆ ನಡುವ ಬರತಿ”and you accused No.2 and 3 intentionally insulted by abusing CW1 and

CW4 in filthy language stating as “ಈ ರಂಡ್ಯಾರಿಗೆ ಸೊಕ್ಕು ಬಹಳ ಬಂದಾದ” thereby gave provocation to CW1 and CW4 intending or knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on her back with hand, you accused No.2 voluntarily caused hurt to CW1 on her back with hand and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Thirdly, that on above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 pulled the hairs of CW1, you accused No.2 pulled the saree of CW1, intending to outrage her modesty or knowing fully well that the intended act is likely to outrage the modesty of the said woman and thereby you have committed an offence punishable U/Sec.354 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.3 criminally intimidated CW1 and CW4 by threatening to take away their lives as “ಈ ರಂಡಿ ಮಕ್ಕಳಿಗೆ ಬಿಡಬೇಡರಿ”, so as to cause alarm in their mind and thereby you have committed an offence punishable

U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
