C H A R G E

*I, **CHANDRAKANTH**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Sadat Ansari S/o. Mahiboob Ansari Karabari,
Aged: 38 years, Occ: Pvt. Work,
2. Pirasat Ansari S/o. Mahiboob Ansari Karabari,
Aged: 36 years, Occ: Pvt. Work,
3. Phurkhan Ansari S/o. Mahiboob Ansari Karabari,
Aged: 26 years, Occ: Pvt. Work,
4. Muktarbegum W/o. Mahiboob Ansari Karabari,
Aged: 66 years, Occ: Housewife,

Above all are R/o. New Ansari Mohalla, Aland.

As follows;

Firstly, that you accused No.1 being the husband of C.W.1- Smt. Ruksarabegum W/o. Sadat Ansari, R/o. New Ansari Mohalla, Aland, Tq: Aland, within the limits of Aland Police Station, after the marriage you accused No.1 to 4 subjected her to cruelty by giving physical and mental torture to her which is of such a nature as is likely to drive her to commit suicide or to danger to life limb or

health and thereby you accused No.1 to 4 have committed an offence punishable U/Sec.498(A) R/w Sec.34 of Indian Penal Code and within my cognizance.

Secondly, that you accused No.1 to 4 in furtherance of common intention picked up quarrel with the C.W.1, have subjected C.W.1 to cruelty by giving physically and mentally torture to her demanding her to bring the dowry gold and money. On failure of fulfilling of illegal demands, you accused subjected C.W.1 to cruelty and thereby you accused No.1 to 4 have committed an offence punishable U/Sec.3 and 4 of D.P. Act and within my cognizance.

Thirdly, that on 11.10.2017 at 4:00 p.m., in furtherance of common intention of you accused No.1 to 4, have intentionally insulted CW1 by abusing her in filthy language as “ರಂಡಿ” and you accused No.4 intentionally insulted CW1 by abusing her in filthy language as “ಏ ರಂಡಿ ಮನೆಯಲ್ಲಿ ಇರಬ್ಯಾಡ ನೀನು ನಿನ್ನ ಗಂಡನೊಂದಿಗೆ ಹೋಗು ಇಲ್ಲದಿದ್ದರೆ ನಿನ್ನ ತವರು ಮನೆಗೆ ಹೋಗು” and thereby gave provocation to C.W.1 intending or knowing it likely that such provocation will cause C.W.1 to break the public peace or to commit any other offence and thereby you accused No.1 to 4 have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code and within my cognizance.

Fourthly, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 4, have voluntarily caused hurt to C.W.1 with hands and thereby you

accused No.1 to 4 have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code and within my cognizance.

Finally, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 4, have criminally intimidated C.W.1 by threatening her to take away her life saying as “ನೀನು ನಮ್ಮ ಮನೆಗೆ ಬಂದರೆ ನಿನಗೆ ಖಲಾಸ ಮಾಡಿಯೇ ಬಿಡುತ್ತೇವೆ” so as to cause alarm in her mind and thereby you accused No.1 to 4 have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
