ಮುಖ್ಯ ವಿಚಾರಣೆ ಮಾನ್ಯ ಸಸಲ ಅವರಿಂದ :

I was worked as a Medical Officer in PHC at Nimbarga from 2005 to 2015.

A patient by name 1) Santosh S/o Chandrasha Gundagurti aged about 25years, were came to our hospital with the history of injuries on 18.10.2013 at about 11.15 a.m. 2) Mahadev S/o Vithal Gundagurti Age. About 23yrs, 3) Pintya S/o Malkapa Gundagurti, Age.23years, were came to our hospital with the history of injuries on 18.10.2013 at about 11.15 to 11.30 a.m.

On examination of the above said Santosh S/o Chandrasha Gundagurti I found the following injury.

1) Abrassion over the forehead measuring 0.5x1 cm red in colour.

On examination of the above said Mahadev S/o Vithal Gundagurti I found the following injury.

1) Swelling on the occipital region measuring 2.5x3 c.m tenderness present.

On examination of the above said Pintya S/o Malkapa Gundagurti, I found the following injury.

- 1) Abrasion over the occipital region of head measuring 0.5x10m red in colour.
- 2) Abrasion over the anterior part of left shoulder measuring 0.5x2 cm.

I have opined that the above mentioned injuries are simple in nature, and might have caused by hard and blunt object. And age of injury was 2 to 4 hours. Witness identify the signatures on the wound certificates, hence wound certificate are marked as Ex.P-3 to Ex.P-5 signature of the witness is marked as Ex.P-3(a) to Ex.P-5(a).

It is true to say that one Revansiddappa and Shivanand were came to our hospital to taking the treatment on same day at 10.00 a.m. It is true to say that I have referred on Revansiddappa for higher treatement to GGH Kalaburagi. It is false to say that I have not mentioned the identification marks in the Ex.P-3, if is true to say that I have not mentioned the identification markes in Ex.P-4 and 5. It is true to said that it is mandatory to mention the minimum two identification marks of the patients in wound certificates. It is true to say that I have mentioned only one identification marks in Ex.P-3. It is true to say that there is an over writing in Ex.P-5 in respect of time. It is true to say that this type of injuries may be caused if any person fell down on the hard surface. It is false to say that only to help the police and CW-1 I have issued the Ex.P-3 to 5. It is false to say that without examining the patients I have issue the Ex.P-3 to 5.
