SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that on 02.06.2014 at 4:35 a.m. you accused being the driver of bus bearing Reg.No.KA-34/F-1017, drove the same on public road i.e. on Aland-Gulbarga road near Kodal Hangarga Village within the limits of Aland Police Station, in a so rash and negligent manner as to endanger human life and personal safety of others and thereby you accused have committed an offence punishable U/Sec.279 of Indian Penal Code and within the cognizance of this Court.

It is further alleged by the prosecution that on the above said date, time and place, you accused drove the above said vehicle in the above said manner and suddenly dashed the vehicle to Pickup van bearing Reg.No.MH-13/N-5817 and caused the accident and due to the said impact, the inmates

of the pickup van by name Nabilal Mulla, Bashasab Mulla, Reshma Mulla, Kamalakar Bargudi, Ramzan Mulla, Sameer Mulla, Mosin Mulla, Noorjahan Mulla, Hussain Mulla, Bawasha Mulla, Maimunbee Mulla, Bismallah Mulla, Mamtaj Mulla, Parveen Mulla, Rihana Shaikh @ Mulla, Jannatbee Mulla, Saddam Mulla, Abdul Rajaq Mulla, Ameen Mulla and driver by name Kamalakar Bargudi sustained grievous injuries to vital parts of the bodies and succumbed to those injuries on the spot and thereby you accused have caused the death of the said deceased persons by your above said rash and negligent act not amounting to culpable homicide and thereby you accused have committed an offence punishable U/Sec.304-A of Indian Penal Code and within the cognizance of this Court.

It is further alleged by the prosecution that on the above said date, time and place, you accused drove the above said vehicle in the above said manner and suddenly dashed the vehicle to Pickup van and caused the above accident due to which the inmates of the vehicle i.e. C.Ws.32 to 35 and 43 sustained grievous injuries and thereby you accused voluntarily caused grievous hurt to them and thereby you accused have committed an offence punishable U/Sec.338 of I.P.C. and within the cognizance of this Court.
