C H A R G E

*I, CHANDRAKANTH, C/c. Addl. Civil Judge & JMFC
Aland, do hereby charge you,*

ACCUSED:

Shivakumar S/o. Nagappa Melkeri,
Aged: 27 years, Occ: Coolie,
R/o. Betjewargi village, Tq:Aland.

As follows;

Firstly, that on 24.09.2019 at 7:00 a.m. at Betjewargi village, within the limits of Narona Police Station, when CW1 to CW3 in their house, you accused asked CW1- Asha Karyakarte to give the RCH number of Tai Card [ತಾಯಿ ಕಾರ್ಡ್] of his wife, after took the number of the said card, you accused on the same day at 7:30 a.m. when CW1 and CW4 were taking water, you accused came there and intentionally intentionally insulted CW1 by abusing her in filthy language stating as “ಏ ರಂಡಿ ನೀನು RCH ನಂಬರ ತಪ್ಪು ಕೊಟ್ಟಿದಿ, ರಂಡಿ ಭೋಸಡಿ” intending or knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you accused has committed an offence punishable U/Sec.504 of Indian Penal Code and within the cognizance of this Court.

Secondly, that on the above said date, time and place, you accused voluntarily caused hurt to CW1 on her back with hand, when CW4 and CW5 came to pacify the quarrel, you accused voluntarily caused hurt to CW4 and CW5 on their back with hand and thereby you, the accused has committed an offence punishable U/Sec.323 of Indian Penal Code and within the cognizance of this Court.

Thirdly, that on the above said date, time and place, you accused picked up quarrel with the CW1 and voluntarily assaulted to CW1 on her left hand elbow with club and caused grievous injury and thereby committed an offence punishable U/Sec.326 of Indian Penal Code and within the cognizance of this Court.

Finally, that on the above said date, time and place, you accused threatened CW1 by threatening her to take away her life as “ಏ ರಂಡಿ ನೀ ಇವತ್ತು ಉಳದಿದಿ ಇನ್ನೊಮ್ಮೆ ಸಿಗು ನಿನಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ” with intent to cause alarm in her mind and thereby you accused has committed an offence punishable U/Sec.506 of Indian Penal Code and within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
