**SUBSTANCE OF ACCUSATION**

It is alleged by the prosecution that on 29.10.2017 at 6:00 p.m., on Koralli – Bhusnoor road, near Bhusnoor factory, within the limits of Nimbarga police station, near the land of Gundappa Kotali, when deceased CW1 and his wife by name Shivakantabai was traveling on a motor cycle bearing registration No.KA-32-EL-0534 from Koralli village to Bhusnoor village to the hospital, you accused being the driver of Jeep bearing registration No.MH-12-BG-7085, drove the same on the above said place, in high speed in a rash and negligent manner so as to endanger human life and personal safety of others and caused injury to deceased CW1 and his wife by name Shivakantabai and thereby you accused has committed an offence punishable U/Sec.279 of Indian Penal Code and within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused drove the above said vehicle in the

above stated manner and suddenly dashed to the above said motor cycle, due to which the inmates of the vehicle i.e. the wife of CW1 by name Shivakantabai sustained grievous injuries and thereby you accused has committed an offence punishable U/Sec.338 of Indian Penal Code and within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused drove the above said vehicle in the above stated manner and caused the accident to CW1 by name Annappa Mangan due to which, he sustained grievous injuries and internal injuries and succumbed to those injuries in the hospital and thereby caused the death of the deceased by your above said rash and negligent act not amounting to culpable homicide and thereby you accused has committed an offence punishable U/Sec.304-A of Indian Penal Code and within the cognizance of this court.

It is further alleged by the prosecution that, on the above said date, time and place, you accused drove the above said vehicle in the above stated manner, caused the accident and after the accident the you accused ran away from the spot without intimating the accident to the nearest police station or taking the injured to the hospital for his treatment and thereby you accused has committed offence punishable U/Sec.187 of IMV Act within the cognizance of this Court.

It is further alleged by the prosecution that, on the above said date, time and place, you accused drove the above

said vehicle in a public road having knowledge that the said vehicle does not have valid insurance and thereby you accused has committed offence punishable U/Sec.188 of IMV Act within the cognizance of this Court.
