**C H A R G E**

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

**ACCUSED:**

1. Laxmi W/o. Karabasappa Chitali,  
Aged: 26 years, Occ: Coolie,
2. Ningamma W/o. Peerappa Naikodi,  
Aged: 60 years, Occ: Coolie,
3. Shivaraj S/o. Peerappa Naikodi,  
Aged: 30 years, Occ: Coolie,

Above all are R/o. Aloor[B] Village, Tq: Aland.

As follows;

Firstly, that on 09.09.2019 at 3:30 p.m. on the border of Aloor[B] Village, in land bearing Sy.No.34 within the limits of Nimbarga Police Station, when CW1, 4 to 7 were working on the above said place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 to 3 came there, you accused No.1 intentionally insulted CW1 by abusing her in filthy language as “ಏ ರಂಡಿ ನನಗೆ ಹೊಲ ಕೊಡಲಾರದೆ ನೀವು ಹೊಲದಲ್ಲಿ ಕೆಲಸ ಹ್ಯಾಂಗ ಮಾಡುತ್ತೀರಿ ನೀವು ಯಾರು ಹೊಲದಲ್ಲಿ ಕೆಲಸ ಏಡಬೇಡಿರಿ,” CW5 came to pacify the quarrel, you accused No.2 intentionally insulted CW5 by abusing her in filthy language

as “ಏ ರಂಡಿ ಅವರ ವಿಷಯದಾಗ ನೀ ಹೊಗಬೇಡಾ” and thereby gave provocation to CW1 and CW5 intending or knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on her back, shoulder, knocked her down on the ground and also kicked on her stomach and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Thirdly, that on above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.2 wrongfully restrained the movement of CW5 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.3 criminally intimidated CW1 and CW5 by threatening to take away their lives stating that “ಏ ರಂಡೆರಾ ನಿಮದು ಬಹಳ ನಡೆದಾದ ನನ್ನ ತಂಗಿ ಹೊಲ ಕೊಡ್ತಿ ಇಲ್ಲ ಅಂದ್ರ ನಿಮ್ಮ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ”, so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
