CHARGE

*I, **Yallappa Kallapur**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Nagaraj S/o. Siddappa Mane,
Aged: 28 years, Occ: Private Work,
2. Subhash S/o. Siddappa Mane,
Aged: 32 years, Occ: Private Work,
3. Siddappa S/o. Gangappa Mane,
Aged: 65 years, Occ: Coolie Work,

Above all are R/o. Honnalli Village, Tq: Aland.

As follows;

Firstly, that on 16.04.2017 at 1:00 p.m. in front of the Dharma School, at Honnalli Village, within the limits of Aland Police Station, you accused No.1 to 3 picked up quarrel with CW1 in furtherance of common intention, when CW1 eating on there, have intentionally insulted CW1 by abusing him in filthy language as “ ಏ ರಂಡಿ ಮಗನೇ ಎಷ್ಟು ಹೊತ್ತು ಊಟ ಮಾಡುತ್ತಿ” and thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause him to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504

R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Secondly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 assaulted CW1 with a stick on his head and caused grievous injury and thereby you have committed an offence punishable U/Sec.326 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Thirdly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.2 bitten to CW1 on his chest, when CW4 came to pacify the quarrel you accused No.3 knocked him down and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Fourthly, that on above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.3 assaulted CW1 with a stone on his mouth and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Finally, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, when CW5 to CW7 were came to pacify the quarrel, you accused No.1 to 3 criminally intimidated CW1 by threatening to take away his life as “ರಂಡಿ ಮಗನೇ ಇವತ್ತು ಉಳಿದಿದ್ದಿ ಇನ್ನೊಮ್ಮೆ ನೀನು ಒಬ್ಬನೇ ಸಿಕ್ಕರೆ ನಿನಗೆ ಖಲಾಸ ಮಾಡಿಯೇ ಬಿಡುತ್ತೇವೆ”, so as to cause alarm in his mind and thereby you have

committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
