**C H A R G E**

*I, YALLAPPA KALLAPUR, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

**ACCUSED:**

1. Ravindra S/o. Bhimasha Mane,

Aged: 35 years, Occ: Coolie,

2. Kalasappa S/o. Rukkappa Mane,

Aged: 65 years, Occ: Coolie,

Above both are R/o. Honnalli village, Tq: Aland.

As follows;

Firstly, that on 16.04.2017 at 1:00 p.m. in front of the Dharma Shala at Honnalli village, within the limits of Aland Police Station, while CW4 was serving the meal on the occasion of Dr. Ambedkar Jayanti, in furtherance of common intention you accused No.1 and 2, have intentionally insulted by CW4 by abusing him in filthy language as “ಏ ರಂಡಿ ಮಗನೆ ಎಷ್ಟು ಹೊತ್ತು ಊಟ ಮಾಡುತ್ತೀ” and thereby gave provocation to CW4 intending or knowing it likely that such provocation will cause CW4 to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, in furtherance of common intention of you accused No.1 and 2, have voluntarily caused hurt to CW4 on his head with chair and caused bleeding injury, if which is used as a weapon of offence is likely to cause death and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, CW5 came to pacify quarrel, you accused No.2 voluntarily caused hurt to CW5 on his left hand with stick and caused internal pain, at that time CW1 asked the above, you accused No.2 pushed the CW1 and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Finally, that on the above said date, time and place, in furtherance of common intention of you accused No.1 and 2, have criminally intimidated CW1 and CW4 by threatening to take away their lives as “ಇವತ್ತು ಉಳಿದಿರಿ ಇನ್ನೊಮ್ಮೆ ಸಿಕ್ಕರೆ ನಿಮಗೆ ಖಲಾಸ ಮಾಡಿಯೇ ಬಿಡುತ್ತೇವೆ” so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

And I hereby direct that you be tried on the said charge.
