The State through Aland P.S.-V/s. – Ramesh and Another.

CHARGE

*I, **Yallappa Kallapur**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Ramesh S/o. Namadev Wade,
Aged: 28 years, Occ: Coolie Work,
R/o. Seeds Foram Tanda, Tq: Aland Dist: Kalaburagi.

2. Lalitabai W/o. Vilas Rathod,
Aged: 30 years, Occ: Coolie Work,
R/o. Navadagi Tanda, Tq: Aland, Dist: Kalaburagi.

As follows;

Firstly, that you accused No.1 being the husband of C.W.1- Laxmibai W/o. Ramesh Wade, R/o. Seeds Foram Tanda, Tq: Aland, the marriage was performed 7 years ago at the above said tanda, after her marriage, you, accused No.1 treated her with cruelty mentally and physically by abusing her and with the active support of you accused No.2 subjected CW1 to cruelty by giving physical and mental torture to her which is of such a nature as is likely to drive her to commit suicide or to danger to life, limb or health and thereby you have committed an offence punishable U/Sec.498(A)

R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Secondly, that on 22.02.2020 at 4:00 p.m. in front of the house of CW1, on public road, within the limits of Aland Police Station, you accused No.1 and 2 in furtherance of common intention, when CW1 and 4 were after completion of Mallayya Mutya Jatra towards his house at the above said place alongwith their children's, you accused No.1 intentionally insulted CW1 by abusing her in filthy language stated that “ ರಂಡಿ ಮಗಳೆ ನೀನು ತವರು ಮನೆಗೆ ಹೋಗು ಅಂತಾ ಹೇಳಿದರು ಹೋಗುತ್ತಿಲ್ಲಾ” and thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause CW1 to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Thirdly, that on above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on her back with club and caused simple injury and thereby you have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Fourthly, that on the above said date, time and place, you accused No.1 and 2 in furtherance of your common intention, you accused No.2 voluntarily caused hurt to CW1 with hands and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Finally, that on the above said date, time and place, you accused No.1 and 2 in furtherance of common intention, you

accused No.1 and 2 criminally intimidated CW1 by threatening to take away her life “ ಬೋಸಡಿ ನೀನು ನಿನ್ನ ತವರು ಮನೆಗೆ ಹೋಗು ಇಲ್ಲದಿದ್ದರೆ ನಿನಗೆ ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲಾ”, so as to cause alarm in her mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

And I hereby direct that you be tried on the said charge.
