C H A R G E

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do
hereby charge you,*

ACCUSED:

1. Basavaraj S/o. Shantappa Kamble,
Aged: 24 years, Occ: Agriculture,
2. Smt. Ambubai W/o. Shantappa Kamble,
Aged: 37 years, Occ: Agri. & Household,
3. Shantappa S/o. Basappa Kamble,
Aged: 2554 years, Occ: Agriculture,
4. Anil S/o. Shantappa Kamble,
Aged: 22 years, Occ: Agriculture,

Above all R/o. Benne Shiroor Village, Tq: Aland,
Dist:Kalaburagi.

As follows;

Firstly, that you accused No.1 being the husband of C.W.1-
Smt.Sujatha W/o. Basavaraj Kamble, R/o. Benne Shiroor village,
Tq: Aland, within the limits of Nimbarga Police Station, after her

marriage, you accused No.1 to 4 treated her with cruelty mentally and physically by abusing her and suspecting her which is of such a nature as is likely to drive her to commit suicide or to danger to life, limb or health and thereby you have committed an offence punishable U/Sec.498(A) R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on 09.03.2020 at 4:30 p.m. at Benneshiroor Village, within the limits of Nimbarga Police Station, when CW1 was in her house, you accused No.1 to 4 in furtherance of your common intention, you accused No.1 intentionally insulted CW1 by abusing her in filthy language stating that “ಏ ರಂಡಿ ನೀ ಎಷ್ಟು ದಿನ ನಮ್ಮ ಮನ್ನಾಗ ಇರ್ತಿ ಇಲ್ಲಿಂದ ಹೋಗು ರಂಡಿ” and thereby gave provocation to CW1 intending or knowing it likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Thirdly, that on above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused No.2 and 4 voluntarily caused hurt to CW1 on her back with hands and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

Finally, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 4, you accused No.3 criminally intimidated CW1 by threatening her to take away her life stating that “ ಈ ರಂಡಿಗೆ ಖಲಾಸ ಮಾಡ್ತಿ” so as to cause

alarm in her mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within the cognizance of this court.

And I hereby direct that you be tried on the said charge.
