2. Vikasrao S/o. Venkatesh Kulkarni,  
Aged: 53 years, Occ: Asst. Engineer,  
R/o. Office of the Asst. Engineer, Irrigation Dept.  
Humanabad, Dist: Bidar.
3. Gopal S/o. Agnihotri,  
Aged: 67 years, Occ: Retd. J.E.  
[I/c. AEE Amarja Dam, Bhusnoor Division]  
R/o. H.No.33/94, Raghavendra Lereted Main Road,  
Surpur, Dist: Yadgir.

4. Late. Sharanappa S/o. Annarao Hangaragi, **[DEAD]**  
Aged: 50 years, Occ: SDA  
at Amarja Dam, Bhusnoor Division,  
H.No.11/45/21/D, Venkateshwar Colony,  
Kalaburagi.

As follows;

Firstly, that you accused No.1 to 3 and one Late. Sharanappa Hangaragi were working for Amarja Project at Bhusnoor in between period from 14.12.1995 to 02.06.2012, in furtherance of your common intention, you accused No.1 to 3 and Late. Sharanappa Hangaragi have misappropriated the salary of the employees, festival advance, traveling allowance and dearness allowances by creating fake documents and submitted it to the office of STO and withdrawn the amount of Rs.32,78,724/- through token No.16 and misused public money and also you accused No.2 and 3 have misused Rs.28,940/- and 29,309/- for personal expenses and committed breach of trust being the State Government employees and thereby you accused No.1 to 3 have committed an offence of criminal breach of trust punishable U/Sec.409 R/w. Section 34 of Indian Penal Code and within the cognizance of this Court.

Secondly, that on the above said date, time and place you accused No.1 to 3 and Late. Sharanappa Hangaragi have cheated government by dishonestly inducing by making duplicate bills and foraging signature on bills/documents and thereby you accused No.1 to 3 have committed an offence punishable U/Sec.420 of

Indian Penal Code and Read With Section 34 within my cognizance of this Court.

Thirdly, that on the above said date, time and place you accused No.1 to 3 and Late. Sharanappa Hangaragi infurtherance of your common intention, have forged the signature and thereby you accused No.1 to 3 have committed an offence punishable U/Sec. 465 Read With Section 34 of Indian Penal Code.

Fourthly, that on the above said date, time and place you accused No.1 to 3 and Late. Sharanappa Hangaragi infurtherance of your common intention, have forged the signature in order to cheat the government as well as the irrigation department and thereby you accused No.1 to 3 have committed an offence punishable U/Sec. 468 Read With Section 34 of Indian Penal Code.

Finally, that on the above said date, time and place you accused No.1 to 3 and Late. Sharanappa Hangaragi infurtherance of your common intention, used the duplicate bills as genuine one dishonestly and fraudulently and thereby you accused No.1 to 3 have committed an offence punishable U/Sec. 471 Read With Section 34 of Indian Penal Code.

And I hereby direct that you be tried on the said charge.
