SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that on 10.02.2020 at 3:45 p.m., on Ambalga Cross Arch to Ambalga villaeg road, near Bridge, on public road, on tumbled-down within the limits of Narona Police Station, you, the accused alongwith CW19 his mother Ratnabai W/o Nagappa Kamble, CW21 her husband of Damu S/o. Toma Rathod, CW11 her grand son Aditya S/o. Baramayya Dandgule alongwith CW8 to 15 were traveling on Mahagaon Cross to Ambalga Village road, you, the accused being the driver of tum tum bearing Reg.No.KA-32/B-1889, drove the said vehicle in a rash and negligent manner so as to endanger human life and personal safety of others and thereby committed an offence punishable U/Sec.279 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you, the accused drove the above said vehicle in the above stated manner and suddenly tumbling on road tum tum vehicle bearing Reg.No.KA-32/B-1889, due to which i.e. CW11 her grand son Aditya and CW8 to 12, 14 and 15 sustained simple injuries and thereby you, the above named accused committed an offence punishable U/Sec.337 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you the accused drove the above said vehicle in the above stated manner and suddenly tumbling on road tum tum bearing Reg.No.KA-32/B-1889, due to which i.e. CW19 his mother Ratnabai and all injured persons, CW21 her husband Damu Rathod sustained grievous injuries and thereby you, the above named accused committed an offence punishable U/Sec.338 of Indian Penal Code and within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you, the accused drove the above said vehicle in the above stated manner and suddenly tumbling on road tum tum bearing Reg.No.KA-32/B-1889 due to which i.e. CW19 his mother Ratnabai on her head sustained grievous/bleeding injury and ran away from the spot and CW21 her husband of Damu Rathod sustained grievous/bleeding injuries to his vital parts of the body and succumbed to those injuries he shifted to Ambalga Govt. Hospital ran away from the spot at

4:15 p.m. and thereby you, caused the death not amounting to culpable homicide of the deceased persons by your above said rash or negligent act and thereby committed an offence punishable U/Sec.304-A of Indian Penal Code, within the cognizance of this court.

It is further alleged that, on the above said date, time and place, you, the accused by driving the above said vehicle in the above stated manner and after causing the above said death, injuries you have failed to inform the fact of accident to the nearest police station and failed to take reasonable steps to secure medical attention for the injured persons and ran away from the spot and thereby committed an offence punishable U/Sec.187 of I.M.V. Act, within the cognizance of this Court.

It is further alleged that, on the above said date, time and place, you, the accused being the driver of the above offending vehicle, drove the said vehicle on the road without coverage of Insurance which is mandatory as per the provision of Motor Vehicles Act and thereby committed an offence punishable under section 192[A] of Motor Vehicles Act, within the cognizance of this Court.
