C H A R G E

*I, YALLAPPA KALLAPUR, Prl. Civil Judge & JMFC
Aland, do hereby charge you,*

ACCUSED:

Siddappa @ Siddaram
S/o. Shrimanth Sagar @ Goundi,
Aged: 31 years, Occ: Coolie,
R/o. Khajuri village, Taluka Aland.

As follows;

Firstly, that on 11.04.2019 at 01:00 p.m. at Khajuri village, within the limits of Aland Police Station, when CW1 was going on a road in front of the government hospital, you accused came from the opposite side armed with axe and pulled the shirt of CW1 and also wrongfully restrained the movement of CW1 from proceeding further to commit certain offence and thereby you have committed an offence punishable U/Sec.341 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused intentionally insulted CW1 by abusing him in filthy language stated that “ಏ ರಂಡಿ ಮಗನೇ ನಿನಗೆ ನಿನ್ನೆ ರಾತ್ರಿ ಪೋನ್ ಮಾಡಿ ಬರಲು ಹೇಳಿದರೂ ಬರಲ್ಲಾ ಅಂತಾ ಹೇಳುತಿ ಭೋಸಡಿ ಮಗನೇ” intending or knowing it to be likely that such provocation will cause him to

break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 of Indian Penal Code, within the cognizance of this Court.

Thirdly, that on the above said date, time and place, you accused voluntarily caused hurt to CW1 on his head with axe and caused bleeding injury, which it used as a weapon of offence, is likely to cause death and thereby you accused have committed an offence punishable U/Sec.324 of Indian Penal Code, within the cognizance of this Court.

Finally, that on the above said date, time and place, you accused threatened CW1 by threatening him to take away his life with intent to cause alarm in his mind and thereby you have committed an offence punishable U/Sec.506 of Indian Penal Code, within the cognizance of this Court.

And I hereby direct that you be tried on the said charge by this Court.
