SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that on 06.10.2016 at 7:00 p.m., when the son of complainant was returning after completing his field work near Jidaga Coman and by taking CW6 pillion rider along with him, on the road of Aland to Waghdhari, within the limits of Aland police station, you accused being the driver of Motor Cycle bearing registration No.8-6924, Engine No.1709M928192, Chessis No.1709F882518, drove the same on the above said place, in high speed in a rash and negligent manner so as to endanger human life and personal safety of others and caused the accident to the son of complainant by name Shivappa Pujari and thereby you have committed an offence punishable U/Sec.279 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused drove the above said vehicle in the

above stated manner due to which the inmates of the vehicle i.e. CW6 pillion rider by name Govind sustained simple injuries and thereby you have committed an offence punishable U/Sec.337 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused drove the above said vehicle in the above stated manner and caused the accident, due to which the inmates of the vehicle i.e. the son of complainant by name Shivappa Pujari sustained grievous injuries on his head, right leg and hands and thereby you have committed an offence punishable U/Sec.338 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused drove the above said vehicle in the above stated manner, caused the accident, Shivappa Pujari due to which, he sustained grievous injuries and internal injuries and succumbed to those injuries in the hospital and thereby caused the death of the deceased by your above said rash and negligent act not amounting to culpable homicide and thereby you have committed an offence punishable U/Sec.304-A of Indian Penal Code, within the cognizance of this court.
