Firstly, that at Bolani village, under Halli Salagar Gram Panchayat, within the limits of Aland Police Station, when CW4 to CW6 and CW8 to CW12 were found at the time of annual audit period that, you accused without making the list of annual budget and estimated cost list for the year 2013-14 and 2014-15, has shown the work done in the land of CW14 to CW23 as ಕೃಷಿ ಗುಂಡಾಗಳು, ಬದು ನಿರ್ಮಾಣ ಮತ್ತು ನಾಲಾ ಬ್ರೀನಿಂಗ್ works from the scheme of Mahatma Gandhi Narega Yojana, you accused has misappropriated by

creating fake documents and committed breach of trust being the agriculturists and Government and thereby you accused have committed an offence of criminal breach of trust punishable U/Sec.409 of Indian Penal Code, within the cognizance of this Court.

Finally, that on the above said date, time and place you accused has cheated the agriculturists and Government by dishonestly inducing by making duplicate bills and foraging signature on bills/documents and thereby you accused has committed an offence punishable U/Sec.420 of Indian Penal Code within my cognizance of this Court.

And I hereby direct that you be tried on the said charge.
