SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that on 19.07.2016 at 1:00 p.m., on Aland- Gulbarga road, near Doginala bridge, on Lad-Chincholi Cross, within the limits of Narona Police Station, when CW1 and his wife alongwith their relatives went to Devala-Ganagapur, visiting Shri. Dattatraya Temple in vehicle cruiser bearing Reg. No.MH-25/R-4583, you accused being the driver of Lorry bearing Reg.No.MH-12/LT-7368, drove the said vehicle in a rash and negligent manner so as to endanger human life and personal safety of others and thereby committed an offence punishable U/Sec.279 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you accused drove the above said vehicle in the above stated manner and suddenly dashed to oncoming cruiser bearing Reg.No.MH-25/R-4583, due to which C.W.1-

Prabhakar, Mangala Ingale, Rajanandini Ingale, Bhagyashree Ingale, Vengatha Ingale, Pandurang Ingale, Kunal Ingale, Mouli @ Krishna Ingale, Padmaja Dombale, Ishwarya Ingale, Samiksha Dombale, Rutuja Ingale, Abijith sustained simple injuries and thereby you committed an offence punishable U/Sec.337 of Indian Penal Code, within the cognizance of this Court.

It is further alleged that on the above said date, time and place, you, the accused drove the above said vehicle in the above stated manner and suddenly dashed to oncoming cruiser bearing Reg.No.MH-25/R-4583 due to which i.e. Mouli @ Krishna Ingale, Fulchand Dharme, Gajabai Ingale, Sanjay Ingale, Krishna Ingale, Sagajabai Alande, Kanthabai Ingale, Varsha Dombale, Swapinal Dombale sustained grievous injuries to their vital parts of the bodies and succumbed to those injuries and thereby you, caused the death of the deceased persons by your above said rash and negligent act, not amounting to culpable homicide and thereby committed an offence punishable U/Sec.304-A of Indian Penal Code, within the cognizance of this court.

It is further alleged that, on the above said date, time and place, you, the accused by driving the above said vehicle in the above stated manner and after causing the above said death, injuries you have failed to inform the fact of accident to the nearest police station and failed to take reasonable steps to secure medical attention for the injured persons and ran

away from the spot and thereby committed an offence punishable U/Sec.187 of I.M.V. Act, within the cognizance of this Court.
