**C H A R G E**

*I, **YALLAPPA KALLAPUR**, Prl. Civil Judge & JMFC Aland, do hereby charge you,*

**ACCUSED:**

1. Suma W/o. Dattu Natikar,  
Aged: 30 years, Occ: Housewife,  
R/o. Dhangapur village, Now at Awarad (K) village.
2. Ravi S/o. Marenna Kodi,  
Aged: 56 years, Occ: Agriculture,  
R/o. Awarad (K) village, Taluka Aland.
3. Lalitabai W/o. Ravi Kodi,  
Aged: 49 years, Occ: Housewife,  
R/o. Awarad (K) village, Taluka Aland.
4. Gunderaya @ Gundu S/o. Annaraya Devanagaon,  
Aged: 34 years, Occ: Agriculture,  
R/o. Udanoor village, Taluka and District Kalaburagi.
5. Basu S/o. Annaraya Devanagaon,  
Aged: 36 years, Occ: Agriculture,  
R/o. Udanoor village, Taluka and District Kalaburagi.
6. Sharanamma W/o. Annaraya Devanagaon,  
Aged: 60 years, Occ: Housewife,  
R/o. Udanoor village, Taluka and District Kalaburagi.

As follows;

Firstly, that on 28.08.2022 at 7:30 p.m. at Nimbarga village in front of the CW1 on a road, within the limits of Nimbarga Police Station, you accused No.1 to 6 by forming an unlawful assembly and in prosecution of common object of the said assembly, namely, to commit rioting, to cause hurt, to intentionally insult and to criminally intimidated and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 6 being members of an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you have committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 6 were members of an unlawful assembly in prosecution of common object, you accused No.1 intentionally insulted CW1 by abusing her in filthy language as “ಏ ರಂಡಿ ನಿನ್ನ ಮಗ ದತ್ಯಾ ಎಲ್ಲಿ ಇದ್ದಾನೆ”, you accused No.2 intentionally insulted CW1 by abusing her in filthy language as “ಏ ರಂಡಿ” you accused No.3 intentionally insulted CW1 by abusing her in filthy language and thereby gave provocation them and also intentionally insulted intending or knowing it to be likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 to 6 were members of an unlawful assembly, in prosecution of common object, you accused No.3 pushed the CW1 on the ground and thereby you have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code, within my cognizance.

Fifthly, that on the above said date, time and place, you accused No.1 to 6 were members of an unlawful assembly, in prosecution of common object, you accused No.2 pulled the hairs of CW1 and used criminal force to CW1 a women with an intention to outrage her modesty and thereby you have committed an offence punishable U/Sec.354 R/w Sec.149 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 6 were members of an unlawful assembly, in prosecution of common object, you accused No.4 to 6 criminally intimidated by threatening CW1 life as “ನಿನ್ನ ಮಗ ದತ್ತು ಮತ್ತು ನಿನಗೆ ಜೀವ ಸಹಿತ ಬಿಡವುಡಿಲ್ಲ”, so as to cause alarm in her mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code, within my cognizance.

And I hereby direct that you be tried on the said charge.
