Firstly, that on 16.10.2019 at 3:15 p.m. on Aland to Hiroli main road, near Old RTO Check Post, at about 100 meter distance within the limits of Excise Police Station, you accused No.1 was found in illegal possession of 480-Original Choice Whiskey(Tetra Pack) of 90 ml each, intending to sell the same without any valid permit or license and thereby you accused has committed an offence punishable U/Sec.11, 12, 14, 15, 32(1) and 43 of Karnataka Excise Act and the same is within the cognizance of this Court.

Finally, that on the above said date, time and place, you accused No.2 being the owner of the vehicle bearing Reg.No.KA-32/EH-5559, knowingly permitted it to be used for the purpose of commission of above said offences without valid permit or license

and thereby you accused has committed an offence punishable U/Sec.38(A) of Karnataka Excise Act, 1965 and the same is within the cognizance of this Court.
