**C H A R G E**

*I, SNEHA PATIL., Addl. Civil Judge & JMFC, Aland, do hereby charge you, as follows;*

Firstly, that on 17.04.2020 at 5:30 p.m. on Kamsurnayak Tanda road, under the bridge, within the limits of Excise Aland, you accused No.1 alongwith another Dhareppa split-up in CC No.5786/2023 were found in illegal possession 288-Original Choice Whiskey(Tetra Packs) of 90 ml each intending to sell the same without any valid permit or license and thereby you accused No.1 has committed an offences punishable U/Sec.11, 12, 14, 15, 32 and 43 of Karnataka Excise Act and the same is within the cognizance of this Court.

Secondly, that on the above said date, time and place, you accused No.2 being the owner of the Hero Honda CD 100 DLX Red Color motorcycle bearing Reg.No.KA-32/J-9057 knowingly permitted it to be used for the purpose of commission of above said offences without valid permit or license and thereby you accused No.1 has committed an offence punishable U/Sec.38(A) of Karnataka Excise Act, 1965 and the same is within the cognizance of this Court.

Lastly, that on the above said date, time and place, you accused No.1 alongwith another Dhareppa split-up in CC No.5786/2023 possessed and transported the above said intoxicants knowing fully well that the same is not fit for human consumption and intended to sell the same and thereby you accused No.1 has committed an offence punishable **U/Sec.273** of Indian Penal Code and the same is within the cognizance of this Court.
