C H A R G E

I, **YALLAPPA KALLAPUR**, *Prl. Civil Judge & JMFC Aland*, do hereby charge you,

ACCUSED:

1. Sagar @ Anil S/o. Sanju Kshirasagar,
Aged: 19 years, Occ: Coolie,
2. Siddaram @ Siddarth S/o. Suryakant Devanur,
Aged: 21 years, Occ: Driver,
3. Prashant S/o. Gurappa Savale,
Aged: 20 years, Occ: Driver,

Above all are R/o. Aaya Jangal, Aland, Tq: Aland.

As follows;

Firstly, that on 29.05.2020 at 3:15 p.m. near the Government Hospital at Aland Town, within the limits of Aland Police Station, when CW1, CW4 and CW5 were on duty, in furtherance of common intention of you accused No.1 to 3 have wrongfully restrained the movement of CW1, CW4 and CW5 from proceeding further and to commit certain offence and thereby you have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code, within my cognizance.

Secondly, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 3, intentionally insulted CW1, CW4 and CW5 by abusing them in filthy language stated that “ನಿನ್ನೆ ನಮ್ಮ ಕೈಗೆ ಸರಿಯಾಗಿ ಡ್ರೆಸಿಂಗ್ ಮಾಡಿಲ್ಲ ಸೂಳೆ ಮಕ್ಕಳು ನಿಮಗ ಸೊಕ್ಕು ಬಂದಾದ” and thereby gave provocation CW1, CW4 and CW5 intending or knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within my cognizance.

Thirdly, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 3, used criminal force on CW1, CW4 and CW5 by way of assaulting with hands and abused them in filthy language when CW1, CW4 and CW5 were on their duty, with an intention to prevent or deter and discharging their duty as a public servants and thereby you have committed an offence punishable U/Sec.353 R/w Sec.34 of Indian Penal Code, within my cognizance.

Fourthly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 by holding the shirt of CW1 and also slapped on his cheek and you accused No.2 voluntarily caused hurt to CW1 on his back with fist and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within cognizance of this court.

Fifthly, that on the above said date, time and place, you accused No.1 to 3 in furtherance of common intention, you accused No.1 voluntarily caused hurt to CW1 on his right hand elbow with stone and caused grievous internal pain injury, if which is used as a weapon of offence is likely to be caused death and thereby you have committed an offence punishable U/Sec.326 R/w Sec.34 of Indian Penal Code, within my cognizance.

Finally, that on the above said date, time and place, in furtherance of common intention of you accused No.1 to 3, have criminally intimidated CW1, CW4 and CW5 by threatening to take away their lives stated that “ಮಕ್ಕಳು ಇನ್ನೊಮ್ಮೆ ನಮ್ಮ ತಂಟೆಗೆ ಬಂದರೆ ನಿಮಗೆ ಖಲಾಸ ಮಾಡುತ್ತೇವೆ”, so as to cause alarm in their mind and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code within cognizance of this court.

And I hereby direct that you be tried on the said charge.
