C H A R G E

*I, **YALLAPPA KALLAPUR**, C/c.Addl. Civil Judge & JMFC Aland, do hereby charge you,*

ACCUSED:

1. Siddaram S/o. Pareppa Gouli,
Aged: 46 years, Occ: Agriculture,
2. Mahesh S/o. Siddaram Gouli,
Aged: 22 years, Occ: Agriculture,
3. Kamalabai W/o. Siddaram Gouli,
Aged: 40 years, Occ: Household,

Above all are R/o. Kinni Abbas Village, Tq: Aland.

As follows;

Firstly, that on 05.05.2020 at 3:30 p.m. on the border of Kinni Abbas Village, within the limits of Madan Hipparga Police Station, the dispute in between you accused persons and CW1 for the bandara of land, when you accused No.1 put the fire to the grass of the said bandara, the fire spread-out to the others landed trees i.e. 20-Sandalwood Trees, 4-Neem Trees and also damaged other 6-7 trees due to the said fire, you accused played mischief by fired with an intent to cause damaged to the trees belonging to CW1 and thereby you, have committed an offence punishable

U/Sec.435 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Secondly, that on 06.05.2020 at 8:30 a.m. at Kinni Abbas Village, within the limits of Madan Hipparga Police Station, when CW1 was near the Hanuman Temple, you, the accused No.1 to 3 in furtherance of common intention, you accused No.1 intentionally insulted CW1 by abusing him in filthy language stating that “ಏನೋ ಬೋಸಡಿ ಮಗನೆ ಸಾಕ್ಷಿ ನಂ.7 ನೇದ್ದವನಿಗೆ ನಾನು ಹೊಲಕ್ಕೆ ಬೆಂಕಿ ಹಚ್ಚಿದ್ದಿನಿ ಎಂದು ಹೇಳುತ್ತಿ ನಿನಗೆ ಎಷ್ಟು ಸೊಕ್ಕು ಇದೆ” and also intentionally insulted CW7 by abusing him in filthy language and thus insulted CW1 and CW7 intending or knowing it to be likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Thirdly, that on the above said date, time and place, in furtherance of above offence and in furtherance of common intention, you, the accused No.1 tightly held CW7 on his neck used a towel and also assaulted CW7 on his stomach and left and right stomach with fist and you, the accused No.2 kicked CW1 and thereby you have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Fourthly, that on the above said date, time and place, in furtherance of above offence and in furtherance of common intention, you, the accused No.2 assaulted CW1 with a stone on his stomach and thereby you have committed an offence punishable

U/Sec.324 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

Fifthly, that on the above said date, time and place, in furtherance of above offence and in furtherance of common intention, you, the accused No.3 used criminal force against CW1 on his left ear and cheek with Chappal with an intention to dishonor him in the society and thereby you have committed an offence punishable U/Sec.355 R/w Sec.34 of Indian Penal Code and within the cognizance of this court.

Finally, that on the above said date, time and place, in furtherance of above offence and in furtherance of common intention, when CW4 to 7 came to pacify the quarrel, you the accused No.1 to 3 threatened CW1 stating that you will take away his life “ಮಗನೆ ನಿನಗೆ ಜೀವ ಸಹಿತ ಬಡುವುದಿಲ್ಲ ಮುಂದೆ ನೋಡಿಕೊಳ್ಳುತ್ತೇನೆ” and thereby you have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code, within the cognizance of this Court.

And I hereby direct that you be tried by this court on the said charge.
